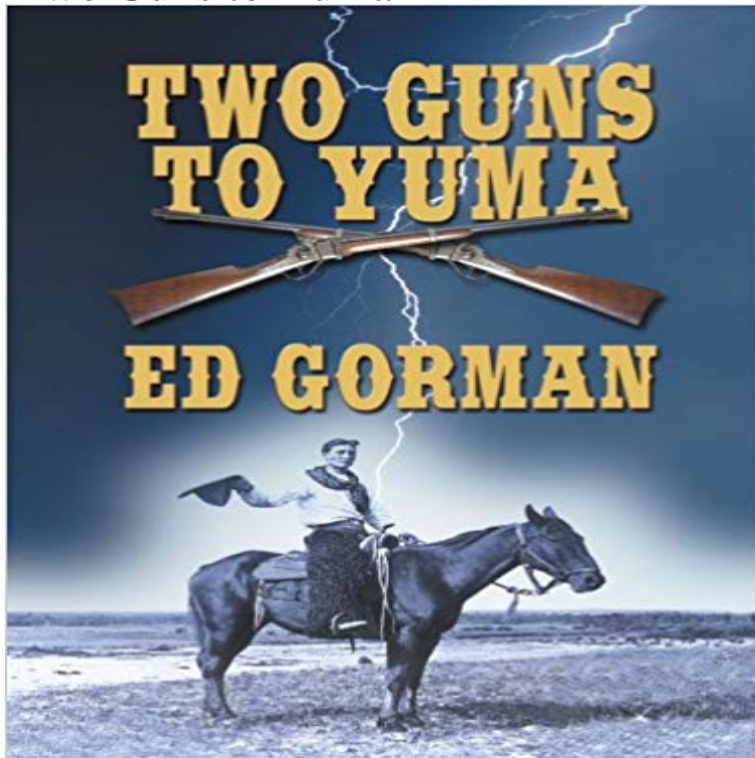


Two Guns to Yuma
