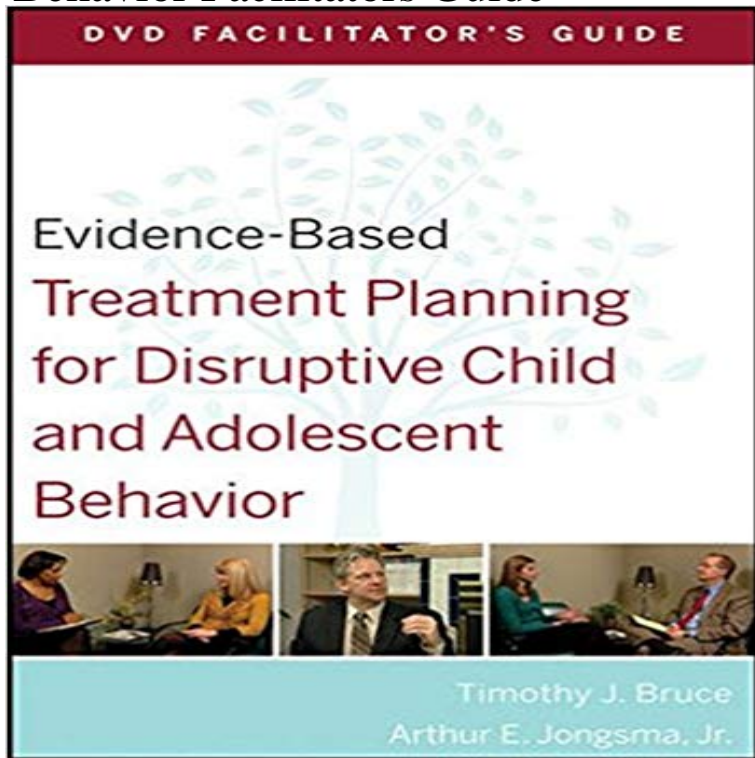


# Evidence-Based Treatment Planning for Disruptive Child and Adolescent Behavior Facilitators Guide
