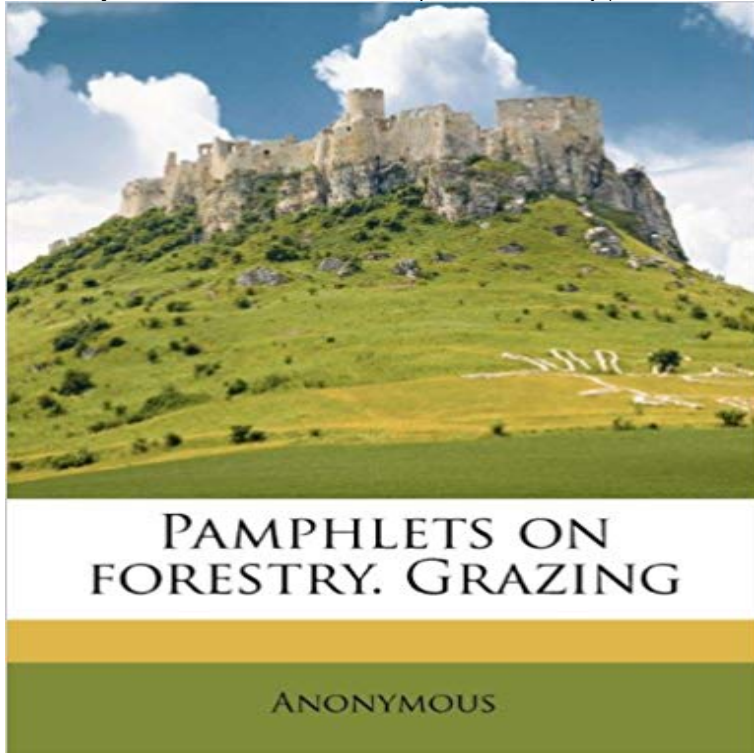


## Pamphlets on forestry. Grazing Volume 6
