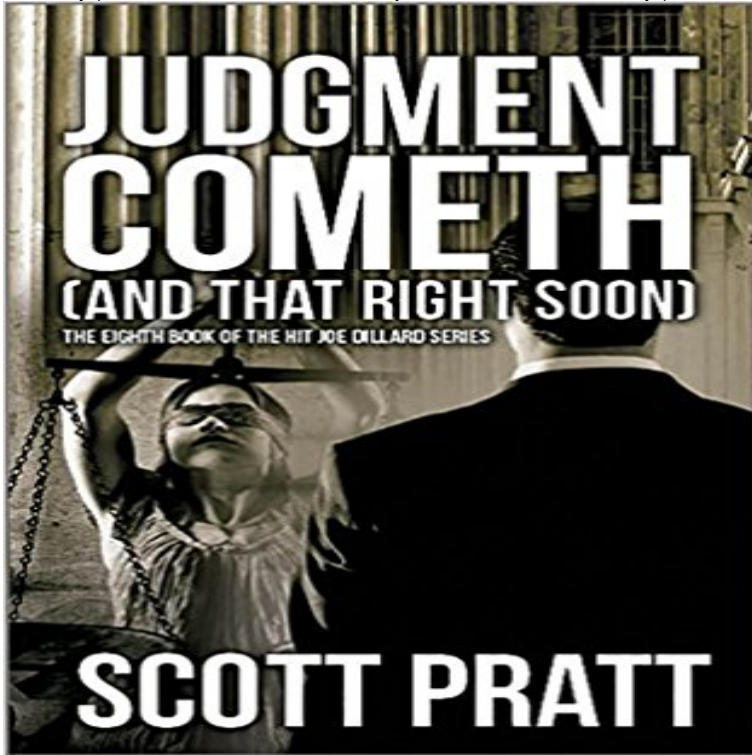


Judgment Cometh: (And That Right Soon) (Joe Dillard Series Book 8)
