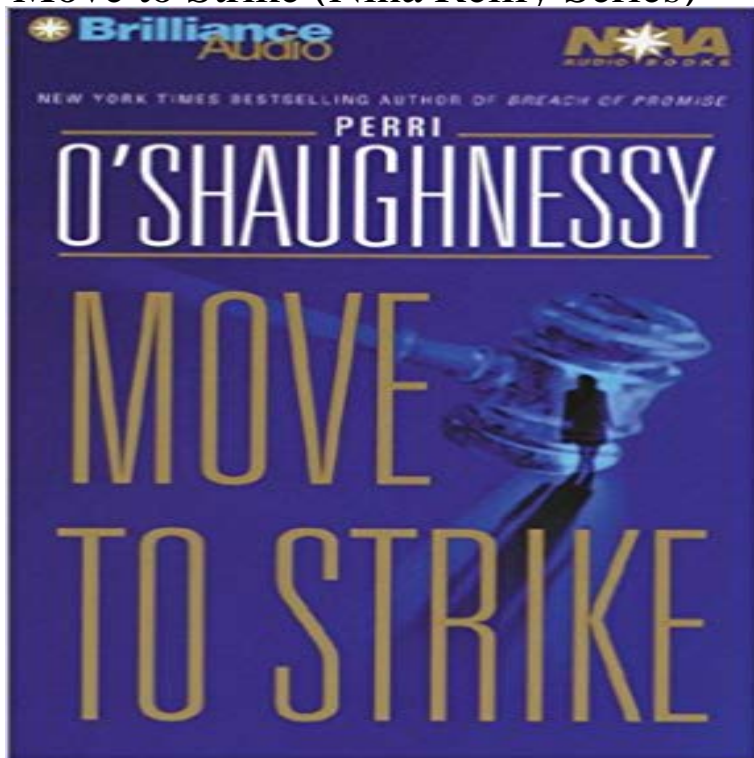


Move to Strike (Nina Reilly Series)
