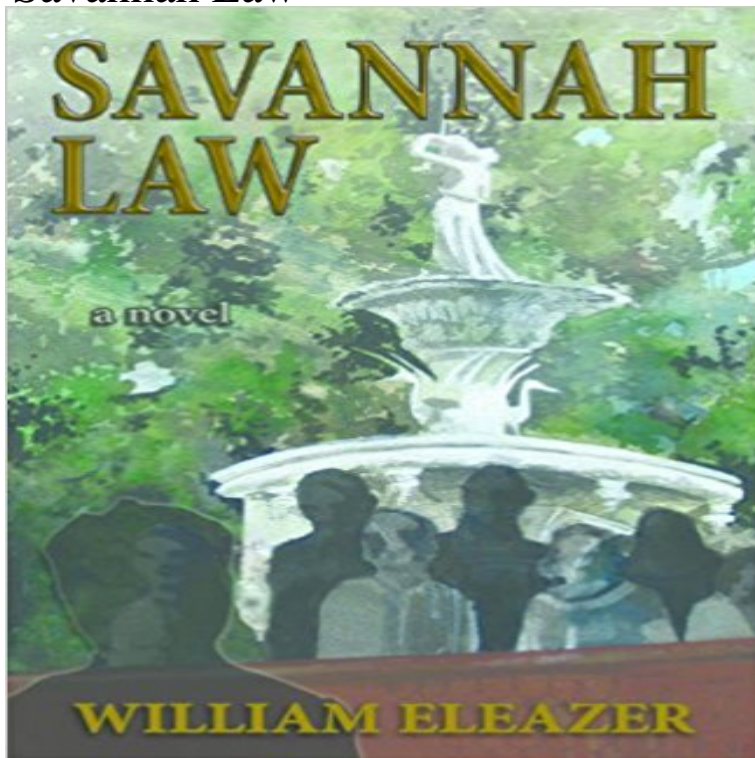


Savannah Law
